A BILL for an Act to create and enact a new section to chapter 50-11.1 of the North Dakota Century Code, relating to early childhood services training and certification requirements; to amend and reenact sections 50-11.1-02, 50-11.1-02.1, 50-11.1-03, and 50-11.1-04, subsection 1 of section 50-11.1-07.2, sections 50-11.1-11, 50-11.1-11.1, and 50-11.1-17, subsection 3 of section 50-11.1-18, and sections 50-11.1-23 and 50-33-08 of the North Dakota Century Code, relating to early childhood services and child care assistance; to repeal sections 50-11.1-02.3 and 50-11.1-02.4 of the North Dakota Century Code, relating to training requirements for early childhood services staff; and to provide an effective date	A BILL for an Act to amend and reenact subsection 11 of section 50-11.1-03 of the North Dakota Century Code, relating to early childhood services training for licensure. BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA: SECTION 1. AMENDMENT. Subsection 11 of section 50-11.1-03 of the North Dakota Century Code is amended and reenacted as follows: 11. Any hours of department-approved training related to child care which an applicant or staff member completes after submitting the fees and application as required under subsection 8 must be counted toward the licensing annual requirements for the following year	A BILL for an Act to create and enact a new section to chapter 50-11.1 of the North Dakota Century Code, relating to the establishment of a child care workforce recruitment and retention program.
